Individuals can also opt into a tax cap of £220,000 (or £440,000 jointly), fixed for five or ten years. There are no capital gains taxes, inheritance taxes, or stamp duty, and new residents may be eligible for a National Insurance refund of up to £4,000.

For those wondering about the property market, the Island operates an open and accessible model—there are no restrictions on who can buy property, and housing is typically more affordable than in other Crown Dependencies, such as Jersey or Guernsey.

Relocating to the Isle of Man is refreshingly straightforward. The Island maintains its own immigration service, with policies that are closely based on UK rules—meaning the visa categories and requirements mirror those of the UK.
