



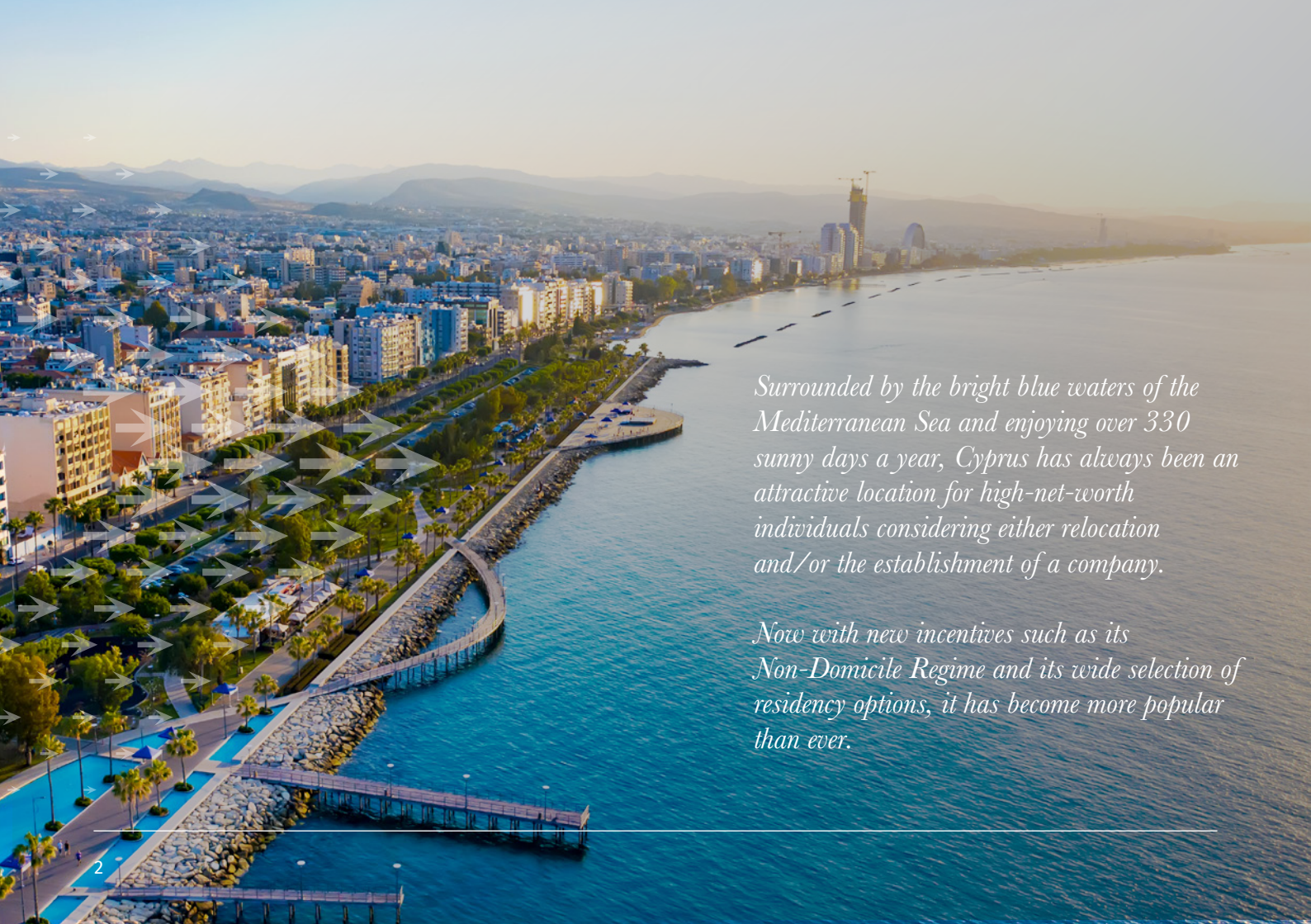

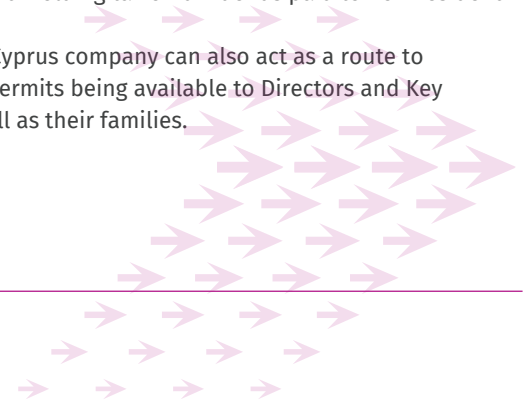
CORPORATE FORMATION AND MANAGEMENT



We have expertise in establishing, managing, administering and advising corporate entities in relation to Cyprus Holding companies, Cyprus Trading companies, royalty structures and the wide array of tax efficiencies that are available. This includes accounting, secretarial and other day-to-day support.

Some of the tax benefits available in Cyprus include:

- Corporation tax of 12.5%, which can be lowered significantly if a company elects to apply the Notional Interest Deduction.
- Dividend income, interest income, FX gains and gains arising from the disposal of shares are all exempt from corporate income tax.
- Cyprus has over 60 double tax treaties, access to the EU directives and applies no withholding tax on dividends paid to non-resident shareholders.
- Establishing a Cyprus company can also act as a route to residency, with permits being available to Directors and Key Personnel, as well as their families.

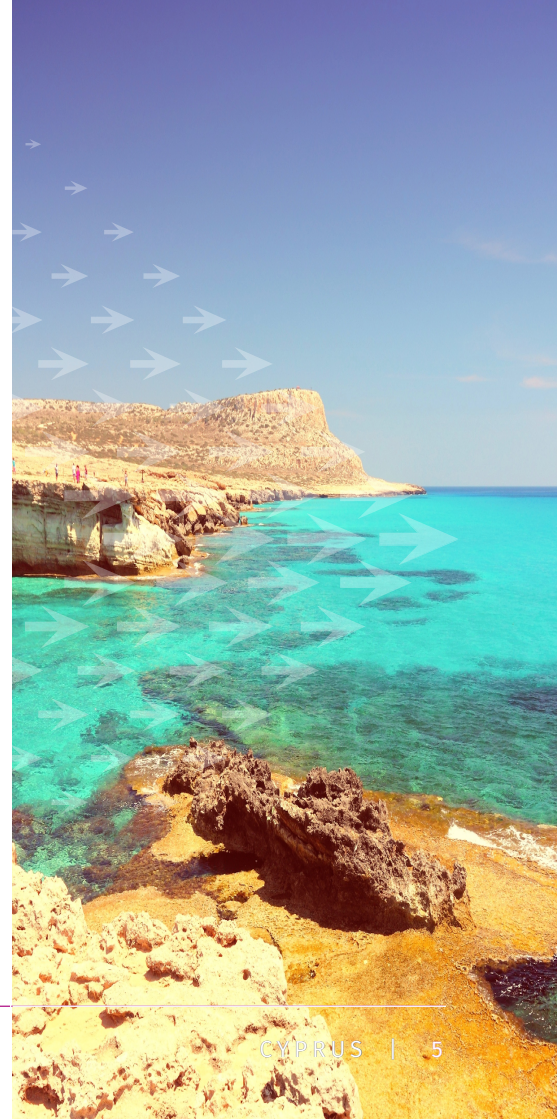

A CIT is widely used by high-net-worth individuals for Asset Protection, tax planning and wealth management.

In addition to the asset protection benefits of a trust, a CIT also offers some unique tax benefits available to the Beneficiaries. These include;

- No Capital Gains Tax is paid on the disposal of assets of a Cyprus trust
- No estate or inheritance tax
- Income received from local or overseas sources is taxable in Cyprus where the beneficiary is a Cyprus tax resident. If beneficiaries are non-tax residents of Cyprus, only Cyprus sources of income are taxable under Cyprus's income tax law.



RELOCATION TO CYPRUS - ADVICE AND COORDINATION

Many high-net-worth individuals relocate to Cyprus due to its excellent living conditions combined with the attractive tax incentives. Cyprus also offers a wide range of options for residency which suit different individuals' needs. Some, like the MEU1 is tailored to EU nationals and others, like the Permanent Residency Program or establishing a foreign interest company, are well suited to 3rd country nationals.

The Non-Domicile tax regime available in Cyprus is among the most advantageous in the EU, with benefits such as;

- Personal income tax exemptions on interest, dividends and capital gains (other than gains on immovable property in Cyprus).
- A tax exemption of 50% or 20% of your salaried income (subject to specific conditions), in addition to the tax free allowance of €19,500.

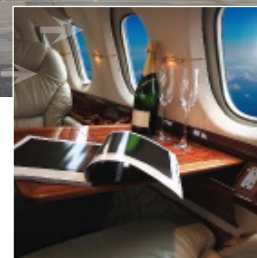
There are also no wealth and no inheritance taxes in Cyprus.
