# CORPORATE FORMATION AND MANAGEMENT

## **Guernsey tax benefits:**

- The general rate of corporate tax payable in Guernsey is zero.
- There are no wealth taxes, no inheritance taxes, no withholding taxes on dividends, no capital gains taxes, and no VAT.
- Guernsey residents pay 20% income tax on Guernsey source income (above a tax-free allowance of £13,025). In certain circumstances individuals can cap the liability on non-Guernsey source income at a maximum £150,000 per annum OR cap the liability on worldwide income at a maximum £300,000 per annum.
- Guernsey is home to more non-UK entities listed on the London Stock Exchange (LSE) markets than any other jurisdiction globally. LSE data shows that in December 2022 there were 105 Guernsey-incorporated entities listed across its various markets.

## *Listed and Corporate Governance Services*

Professional company secretarial and corporate governance services are available to national and international corporations, whether already listed or intending to list on a recognised stock exchange (such as the London Stock Exchange (LSE), the London Alternative Investment Market (AIM), the Aquis Stock Exchange (AQUIS), the Toronto Stock Exchange (TSX), Australia Stock Exchange (ASX), or any others, which Dixcart has had extensive experience with) or where an institution simply needs support in their corporate secretarial and governance process.
