Dixcart UK advises families how to structure their wealth to meet their objectives as well as their particular circumstances. We provide expertise in relation to the UK Remittance Basis of Taxation, which is available to UK non-doms.

UK tax resident, non-domiciled, individuals who are claiming the remittance basis of taxation, do not pay UK tax on foreign income and gains, as long as these are not remitted to the UK.

It is, however, crucial to ensure that this tax benefit is properly planned for and claimed. Failure to plan properly, before arriving in the UK and becoming UK tax resident, could mean that certain available benefits are lost.

CORPORATE FORMATION AND MANAGEMENT

- Most dividend income is tax exempt
- Most substantial share disposals in trading and/or holding companies are tax exempt
- There is a very good double tax treaty network to minimise withholding taxes on dividends, interest and royalties received by a UK company
- There is no withholding tax on the distribution of dividends
- An election is available to exempt overseas branches from UK taxation
- Informal tax clearances are available
- Controlled Foreign Company Legislation only applies to narrowly targeted profits

Additionally, Dixcart UK can advise on all aspects relating to the taxation of UK companies and the potential efficiencies available, as well providing professional UK directors, in the correct circumstances.

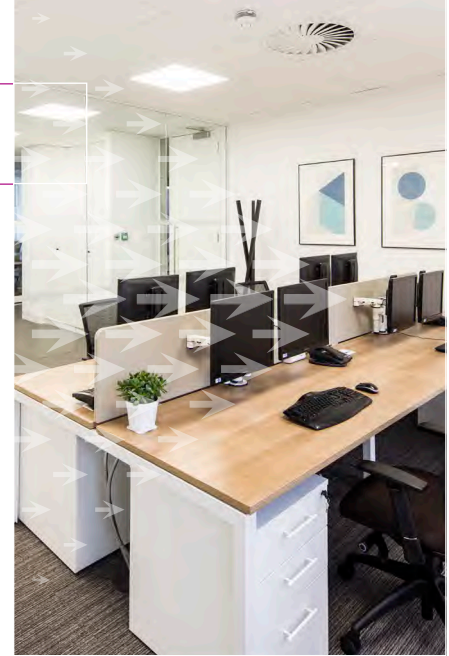

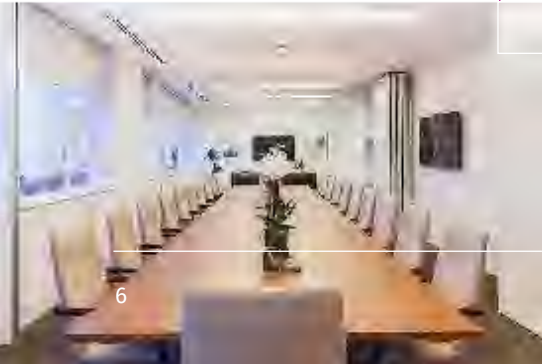
